

# Electronic Funds Transfer Authorization Form

Use this form to set up an Electronic Funds Transfer (EFT) link between your domestic bank and your Folio Investing account only in instances where the Folio account registration is not an exact match with the bank account registration. For example, use this form to establish an EFT link between an individual account at your bank and a Folio Investing joint account. In all other cases, set up the EFT link online.

## Instructions

1. Complete this form for each EFT link to be established, where the link cannot be set up online.
  - Submit an original, preprinted voided check for the account to be linked.
2. For saving accounts, attach an original, preprinted deposit slip.
